Guardian Management – Key Players



Minor Golfer

- Golfer who is 12 years of age or younger per the date of birth in their golfer profile.
- Must be linked to a guardian (or guardians) who can access ghin.com or the GHIN Mobile App and post on their behalf.



Junior Golfer

- Golfer who is between the ages of 13-18 as per the date of birth in their golfer profile.
- Can be linked to a guardian but it is not required.
- A junior will have to provide an email address if they do not have a guardian.



Guardian

- Can be assigned to more than one minor.
- A guardian does not have to have a GHIN #.
- A guardian can access ghin.com or the GHIN Mobile App and post on behalf of a minor.

Adding/Editing a Minor

When the birthdate provided indicates that the golfer is a minor, a new section will be added to the bottom of the form to collect guardian information.

Adding/Editing a Minor (Guardian with GHIN #)

If the user indicates that the guardian has a GHIN number, the necessary information from the golfer's profile will be used.

They will also need to identify what the guardian's relationship is to the minor.

Note: The birthdate provided indicates this golfer is a minor. A guardian is required for golfers less than 13 years of age. The guardian must be at least 19 years of age.

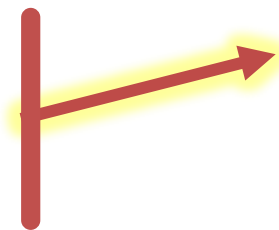

Adding/Editing a Minor (Guardian without a GHIN #)

If the user indicates that the guardian DOES NOT have a GHIN number, they will need to provide the required information manually.



Note: The birthdate provided indicates this golfer is a minor. A guardian is required for golfers less than 13 years of age. The guardian must be at least 19 years of age.

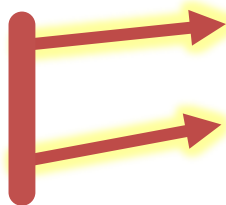

Adding/Editing a Junior

When the birthdate provided indicates the golfer is a JUNIOR, the user has the option of assigning a guardian.



Note: The birthdate provided indicates this golfer is a Junior (between the ages of 13-18). A guardian is not required, but can be added for Junior golfers. The guardian must be at least 19 years of age.

Minors

- Minor can no longer post on kiosk, ghin.com or the GHIN Mobile App
- A guardian is required
- Guardian can post scores for the minor on ghin.com & the mobile app

Golfer Products Impact

- **January 2021**
 - When a guardian logs in to the GHIN Mobile App or ghin.com, if they have any minors tied to their account, they will select which golfer they are accessing the products as (similar to how we handle multi-club members on the GHIN Mobile App)
 - Additionally, guardians will be able to change the golfer they are accessing the GHIN Mobile App and ghin.com as within the Menu
 - This feature will not be available on the Kiosk and minors will not be able to access the Kiosk
