Local Rules & Notice to Competitors

The Rules of Golf, Mass Golf Hand Card, and Terms of Competitions for Mass Golf Championships govern all play except as modified by the following local rules:

Scorecard: The Indian Pond CC scorecard is unofficial and has no status.

Tees: Championship Division **RED** tee markers; Lowery Division **GOLD** tee markers; Women's Division **BLUE** tee markers.

Out of Bounds: Defined by the inside edge at ground level of all white stakes, white lines, and boundary fence posts. All parking areas are OUT of BOUNDS and are defined by the paved edge of the parking lot.

Hole #1 – Right

Hole #11 – Left

Hole #2 – Right (starts 100 yards from green)

Hole #15 – Left

Hole #4 – Left (stops 100 yds from green)

Hole #16 – Left & Behind Green

Hole #10 – Left

Red Penalty Areas: Defined by red stakes or lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #1 – Left off Tee

Hole #12 – Left

Hole #2 – Left of and Behind Green

Hole #13 – Left off Tee

Hole #5 – Left of Green

Hole #14 – Left

Hole #9 – Left of Green

Hole #16 – Left of Green

Hole #10 – Right of Green

Yellow Penalty Area (Hole #5): Defined by yellow stakes or lines. In the absence of a line, the stakes define the edge of the penalty area.

As an additional relief option under Rule 17, for a ball crossing the edge of the yellow penalty area and coming to rest in the penalty area, a player may use the drop zone provided (approx. 95 yards).

Abnormal Course Conditions: All cart paths (paved or unpaved), roads (paved or unpaved), their immediate extensions/adjacent worn areas and white lined areas tying into cart paths. Relief may be taken under Rule 16.1. Buildings/sheds right of #18 and left of #14 are immovable obstructions.

Hole #14 –The area of buildings/sheds/pavement enclosed with a BLUE line is considered one immovable obstruction.

Moveable Obstructions: All starting/scoring tents, and PVC logo signage (including anchor stakes) are movable obstructions. Relief may be taken under Rule 15.1.

Ground Under Repair: Areas enclosed with white painted lines are GUR. Relief may be taken under Rule 16.1.

Immovable Obstructions Close to Putting Greens: For a ball in the general area, relief may be taken under 16.1b when both the ball and obstruction lie in an area cut to **fairway height or less**. The obstruction must be located: i.) On or within two club-lengths of the putting green, ii.) On the player's line of play, and iii.) The ball must be within two club-lengths of the obstruction.

Integral Objects: All stone walls and rock outcroppings are integral objects, relief without penalty is NOT permitted.

Pace of Play: Pace for this round is 4 hours and 35 minutes. Please ensure that you are keeping within a hole of the group in front of you and within the time par printed on your scorecard.

Cut: After 36-holes (or another number determined by the committee) there will be a cut to the low 30 & ties and the Championship Division and the low 12 & ties in the Lowery and Women's Divisions.
