Local Rules & Notice to Competitors

The Rules of Golf, Mass Golf Hard Card, and Terms of Competitions for Mass Golf Championships govern all play except as modified by the following local rules:

Scorecard: The Sagamore Spring Golf Club scorecard is unofficial and has no status.

Tees: Play will be from the **BLACK** tee markers.

Out of Bounds: Defined by the inside edge at ground level of all white stakes, white lines, white dots, public roads (including curbing), boundary fence posts and club parking lot.

Hole #7 – Right of Green

Hole #8 – Left of Green

Hole #9 – Left of Green

Hole #10 – Left & Behind Green

Hole #11 – Left

Hole #15 – Left

Hole #18 – Behind Green

Model Local Rule A-6: Where a boundary is defined by the inside edge of a public road (including curbing) - permanent white-steel stakes with **YELLOW STRIPES** have been placed for visibility. These stakes are immovable obstructions.

Note: A ball that crosses a boundary/public road and comes to rest beyond that boundary/public road is **OUT OF BOUNDS**, even though it may lie on another part of the golf course.

Red Penalty Areas: Defined by red lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #8 – Right

Hole #9 – Right

Hole #10 – Right

Hole #12 – Left of Green

Hole #13 – Right off Tee

Hole #15 – Right & Front of Tee

Hole #16 – Crossing & Right

Hole #17 – Behind Green

Hole #18 – Crossing

Yellow Penalty Areas: Defined by yellow lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #8 – Crossing

Hole #9 – Crossing

Hole #10 – Front of Tee

Abnormal Course Conditions: All cart paths (paved or unpaved), roads (paved or unpaved), their immediate extensions/adjacent worn areas and white lined areas tying into cart paths. Relief may be taken under Rule 16.1.

Ground Under Repair: Areas enclosed with white painted lines are considered GUR. Relief may be taken under Rule 16.1.

Hole #10: As and additional relief option for the area of GUR left of/behind the green, a player may use the drop zone provided.

Hole #15: As and additional relief option for the area of GUR short/left of the green, a player may use the drop zone provided.

No Play Zones: All cultivated flower beds are **NO PLAY ZONES**. Relief **MUST** be taken under Rule 16.1f.

Integral Objects: All stone walls and rock outcroppings are integral objects, relief without penalty is **NOT** permitted.

Pace of Play: Pace for this round is 4 hours and 30 minutes. Please ensure that you are keeping within a hole of the group in front of you and within the time par printed on your scorecard.
