Local Rules & Conditions of Competition

The Rules of Golf, Mass Golf Hard Card, and Terms of Competitions for Mass Golf Championships govern all play except as modified by the following local rules:

Scorecard: The Brockton CC scorecard is unofficial and has no status.

Tees: Play will be from the **BLUE** Markers for both the front and back side.

Out of Bounds: Defined by the inside edge, at ground level, of all white painted lines, white stakes, fence posts, and public roads (*Samuel Ave*). The out of bounds behind the green on Hole #7 & #16 is defined by the stonewall.

Hole #5 & #14 - Right

Hole #6 & #15 - Right (*Samuel Ave*), Left of, and Behind Green (*Driveway, Parking Lot*)

Hole #7 & #16 - Right (*Parking Lot -> Fence*), Behind (*Stonewall*)

Hole #8 & #17 - Right

Hole #9 & #18 - Right (*Driveway*)

Note: A ball which crosses the club driveway or parking lot and comes to rest beyond that is **OUT OF BOUNDS**, even though it may lie on another part of the golf course.

Note: When Out of Bounds is defined by a stonewall, a ball is considered Out of Bounds when it is completely **OVER** the stonewall.

Yellow Penalty Areas: Defined by yellow lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #3 & #12 - Fairway Crossing

Hole #4 & #13 - Fairway Crossing

Red Penalty Areas: Defined by red lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #1 & #10 - Right

Hole #4 & #13 - Left, Right

Hole #2 & #11 - Left, Behind Green

Hole #5 & #14 - Left, Right, and Behind Tee

Hole #3 & #12 - Left, Right, Behind Green **Hole #8 & #17** - Left of, Right of, and Behind Green

PREFERRED LIES: When any part of a player's ball touches a part of the General Area cut to fairway height or less, the player may take free relief once by **LIFTING & PLACING** the original ball or another ball within one club length that is not nearer the hole than the spot of the original ball and is in the General Area. The ball may also be cleaned when lifted.

Immovable Obstructions: All cart paths (paved or unpaved), roads (paved or unpaved), their immediate extensions/adjacent worn areas, white lined areas tying into cart paths. Relief may be taken under Rule 16.1.

Note: Hole #9 & #18 ONLY - As an additional relief option for the flowerbeds, patio, clubhouse building and walkways, and 1st tee box stonewall foundation (all one obstruction, defined by the **GREEN** stakes), a player may use the nearest of the two (2) drop zones provided.

Integral Parts of the Golf Course: All stonewalls, and rock outcroppings are integral parts of the golf course, relief without penalty is NOT permitted- *with the exception of the stonewall adjacent to the 9th/ 18th green as mentioned above.*

Ground Under Repair: Areas enclosed with white painted lines are considered GUR. Relief may be taken under Rule 16.1b.

Pace of Play: Pace for this round is 4 hours and 30 minutes. Please ensure that you are keeping within a hole of the group in front of you and within the time par printed on your scorecard.
