Local Rules & Notice to Competitors

The Rules of Golf, Mass Golf Hard Card, and Terms of Competitions for Mass Golf Championships govern all play except as modified by the following local rules:

<u>Scorecard</u>: The Bass River GC scorecard is unofficial and has no status.

Tees:

-The *Championship Division* will play from the **RED** Mass Golf Tee Markers. -The *Silver Division* will play from the **BLUE** Mass Golf Tee Markers. -The *Junior-Mite Division* will play from the **BLACK** Mass Golf Tee Markers.

Out of Bounds: Defined by the *inside edge* at ground level of all white stakes, white lines, boundary fence posts, public roads, and the Club's driveway.

Hole #5 – Right (<i>Stakes</i>), Behind Green (<i>Road</i>)	Hole #8 – Right (Stakes -> Road)
Hole #6 – Right (<i>Road</i>)	Hole #9 – Right (Driveway -> Fence -> Fence)
Hole #7 – Right & Behind Green (Road -> Stakes -> Line)	Hole #15 – Left (Fence)

<u>Red Penalty Areas</u>: Defined by red lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #1 – Right	Hole #14* – Left & Behind Green
Hole #2 – Right	Hole #15* – Left of & Behind Green
Hole #4 – Right of Green	Hole #16 – Left
Hole #5 – Right off Tee	Hole #17 – Left & Behind Green
Hole #13 – Left	Hole #18** (No Play Zone) – Left

***Note:** As an additional relief option for a ball that crosses the edge of the Red Penalty Area between the **BLUE** stakes (behind the Green) on **Holes 14 & 15**, a player may use the nearest of the two drop zones provided.

****Note:** As an additional relief option for the No Play Zone (identified by Red Stakes with Green tops) left of the Green on **Hole 18**, a player may use the drop zone provided (short of the left greenside bunker).

<u>Abnormal Course Conditions</u>: All cart paths (crushed shell, paved or unpaved), roads (paved or unpaved), their immediate extensions/adjacent worn areas and white lined areas tying into paths. Relief may be taken under Rule 16.1. Crushed shells are loose impediments.

Note: The protective netting (and their support poles) near the 9th Green & 11th Tee is an immovable obstruction. As an additional relief option (including line of play relief), a player may use the drop zone provided.

Integral Objects: All stonewalls, and rock outcroppings are integral objects, relief without penalty is NOT permitted.

Pace of Play: Pace for this round is 4 hours and 30 minutes. Please ensure that you are keeping within a hole of the group in front of you and within the time par printed on your scorecard.

Playoff: Any tie(s) for the final match play qualifying spot(s) will be decided by a hole-by-hole playoff on Tuesday, August 6th (*Holes 1 & 12 – unless otherwise approved by the Committee*).
