Local Rules & Conditions of Competition

The Rules of Golf, Mass Golf Hard Card, and Terms of Competitions for Mass Golf Championships govern all play except as modified by the following local rules:

Scorecard: The Wedgewood Pines CC scorecard is unofficial and has no status.

Tees: Play will be from the **WHITE** tee markers.

Out of Bounds: Defined by the inside edge at ground level of all white painted lines, white stakes, boundary fence posts, club parking lot(s), and club driveway(s). When **OB** is defined by a **stonewall**, a ball is considered **OB** when it is completely **OVER** the stonewall.

Hole #4 - Behind Green (*Driveway & Parking Lot*)
Hole #5 - Right off Tee (*Driveway*)
Hole #7 - Right of Green (*Driveway & Parking Lot*)
Hole #9 - Left (*Stonewall*), Behind Green (*Pool Fence*)

Hole #12 - Behind Green (*Stonewall*)
Hole #15 - Behind Green (*Stonewall*)
Hole #16 - Left (*Stonewall*)
Hole #17 - Left (*Stonewall* -> *transitions to Red Penalty Area*)
Hole #18 - Left of Green (*Parking Lot*)

Note: A ball which crosses the club driveway or parking lot and comes to rest beyond that is **OUT OF BOUNDS**, even though it may lie on another part of the golf course.

Yellow Penalty Areas: Defined by yellow lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #6 - Front of Tee
Hole #8 - *Front of Tee**, Fairway Crossing
Hole #10 - Front of Tee

Hole #13 - Fairway Crossing
Hole #14 - *Front of Tee***
Hole #17 - Fairway Crossing
Hole #18 - Fairway Crossing

****The Yellow Penalty Area on Hole #8 can be treated as a Red Penalty Area while playing Hole #7****

*****The Yellow Penalty Area on Hole #14 can be treated as a Red Penalty Area while playing Hole #10*****

Red Penalty Areas: Defined by red lines. In the absence of a line, the stakes define the edge of the penalty area.

Hole #5 - Right of & Behind Green***
Hole #6 - Left, Right, Behind Green
Hole #7 - Left, Right, Behind Green***
Hole #8 - Right, Left of & Behind Green
Hole #9 - Right, Left
Hole #10 - Left
Hole #18 - Behind Green***

Hole #11 - Right, Left
Hole #12 - Right of Tee, Left
Hole #13 - Left of Green
Hole #14 - Left of Green
Hole #15 - Left off Tee
Hole #17 - Left (*after transition from OB*), Right

Note: As an additional relief option for the specific Red Penalty Areas marked with ***, a player may use the nearest of the two drop zones provided.

Note: The Drop Zones on Holes #7 and #18 may also be used as an additional relief option for the Cart Path's behind the green on each hole.

Abnormal Course Conditions: All cart paths (paved or unpaved), roads (paved or unpaved), their immediate extensions/adjacent worn areas, and white lined areas tying into cart paths. Relief may be taken under Rule 16.1.

Immovable Obstructions Close to Putting Greens: For a ball in the general area, relief may be taken under 16.1b when both the ball and obstruction lie in an area cut to fairway height or less. The obstruction must be located: i.) On or within two club-lengths of the putting green, ii.) On the player's line of play, and iii.) The ball must be within two club-lengths of the obstruction.

Ground Under Repair: Areas enclosed with white painted lines are considered GUR. Relief may be taken under Rule 16.1b.

No Play Zone(s): The Turf Nursery on the left side of Hole #3 is a No Play Zone. Relief **MUST** be taken under Rule 16.1f.

Integral Objects: All stonewalls, and rock outcroppings are integral objects, relief without penalty is **NOT** permitted.

Pace of Play: Pace for this round is 4 hours and 30 minutes. Please ensure that you are keeping within a hole of the group in front of you and within the time par printed on your scorecard.
